

## Racing Queensland RTO (RTO 31452) – Change of Fees

Racing Queensland RTO wishes to advise students and stakeholders of an upcoming change to our fee structure, which will take effect from **5 May 2026**.

**This is our first fee adjustment since 2017.** Over the past seven years, the cost of delivering high-quality, nationally accredited training has steadily increased—particularly in relation to compliance, training resources, educator development, and student support across regional areas. These fee changes are essential to ensure the long-term sustainability and quality of our training delivery and product.

While fees are changing, our commitment to accessible training and personalised student support remains unchanged. Our updated fee structure will allow us to:

- Maintain high-quality delivery and up-to-date learning materials
- Support our experienced trainers and their professional development
- Invest in student support and regional service delivery
- Meet national compliance standards and audit obligations
- Continue providing industry-aligned, practical training outcomes

Our revised fees remain in line with national benchmarks and reflect the true cost of maintaining a trusted, safe, and respected RTO.

All additional revenue from these changes will be reinvested into improving the student experience, updating technology and resources, and enhancing industry engagement.

- The fee of \$1.60 per nominal hour is the student fee contribution applied to each unit of competency delivered under the Skills Assure Supplier (SAS) funding arrangement for Apprenticeships and Traineeships.
- The fee is calculated using the nationally endorsed nominal hours (NCVER) for the unit and contributes to the cost of training delivery.
- The amount is a fixed, government-set amount, applies uniformly across all SAS providers, and must not be varied by providers.
