**Schedule for the Magic Millions 2021 Gold Coast March Yearling Sale - QTIS Pay Up Promotion**

<b>Promotion Name</b>	Queensland Thoroughbred Incentive Scheme ( <b>QTIS</b> ) Pay Up Promotion.
<b>Promoter</b>	Racing Queensland Board (trading as Racing Queensland) ABN 80 730 390 733 of Racecourse Road, Deagon, Queensland 4017.
<b>Permit Numbers</b>	Not applicable.
<b>Promotion Period</b>	The Promotion starts at 8.00am AEST on Monday, 15 March 2021. The Promotion closes at 3.00pm AEST on Tuesday, 16 March 2021. No entries will be accepted after this time.
<b>Relevant State(s)</b>	Queensland.
<b>Entry Restrictions</b>	Entry is open to attendees at the Magic Millions 2021 Gold Coast March Yearling Sale ( <b>Sale</b> ) aged 18 years or older at the commencement of the Promotion ( <b>Eligible Entrants</b> ).  Eligible Entrants must be able to provide a valid telephone number and email address for entry into the Promotion.
<b>Entry Procedure</b>	To enter, Eligible Entrants must:  (1) go to the Racing Queensland/Thoroughbred Breeders Queensland Association marquee ( <b>Marquee</b> ) at the Sale;  (2) complete the electronic submission form ( <b>Submission Form</b> ) using one of the iPads provided by a Racing Queensland or Thoroughbred Breeders Queensland Association representative inside the Marquee, including providing all of the requested details (including full name, mobile number and email address); and  (3) click the 'Submit Entry' button on the Submission Form.  If the Submission Form is incomplete or not submitted the Eligible Entrant's entry will be invalid.  There is a maximum of one entry per Eligible Entrant. Eligible Entrants who enter more than once will be ineligible to win a Draw.  Eligible Entrants will be eligible to win a Draw only once.
<b>Verification Requirements</b>	As set out in the Prize Acceptance section below.

### Terms and Conditions of Entry for the Magic Millions 2021 Gold Coast March Yearling Sale – QTIS Pay Up Promotion

#### First up

1. These terms and the Schedule form the Conditions of Entry for this Promotion, and set out all of the information you need to know regarding this Promotion. Capitalised terms have the meaning given in the Schedule, unless otherwise stated. If there's any inconsistency between these terms and the Schedule, then what's in the Schedule is correct. By submitting your entry, you agree that these Conditions of Entry apply to your entry.
2. **The promoter is the Racing Queensland Board (trading as Racing Queensland) ABN 80 730 390 733 of Racecourse Road, Deagon QLD 4017 ('Promoter', 'we', 'us').**

#### Who can enter ... and who can't

4. The eligibility requirements for this Promotion are set out in the Entry Restrictions.
