## IN FOAL REBATE CLAIM FORM

For the 2020/21 Standardbred Breeding Season (1 August 2020 to 31 January 2021) Racing Queensland will be assisting breeders through the 'In Foal' rebate (\$500 per mare) to help support breeders with the financial impacts of COVID-19 and the ongoing drought in South East Queensland.

To be eligible for the rebate, breeders must complete this form in full and meet the following conditions:

- The mare must be a standardbred registered with Harness Racing Australia.
- The mare must be inseminated in Queensland by a standardbred stallion registered with Harness Racing Australia.
- A positive 42 day pregnancy test must be evidenced.
- The mare must be agisted in Queensland throughout the pregnancy. The breeder must not have already been paid an 'In Foal' rebate in respect of more than 6 separate mares in FY 2020/21.
- The form must be submitted to Racing Queensland by 31 March 2021.
