We are looking forward to welcoming thousands of guests on the 13th of January for Magic Millions Raceday 2018. As you are all aware it is a hot and busy day and the last thing we want is for Trainers and their Owners to stand in line.

To make entry to the racecourse run smoothly we will have a separate access point for Trainers and Owners as well as access to pick up passes and tickets 3 days prior to raceday.

All Trainers who have a runner on Magic Millions raceday <u>must</u> obtain their ticketing to receive:

Access to:

- Horse Stalls
- The downstairs member's areas
- Owners and Trainers Precinct
- Mounting Enclosure

You will be given ONE additional guest pass which will have all of the entitlements listed above. For any additional tickets, please submit a 'special request' to membership@gctc.com.au prior to raceday.

If you are a trainer and wish to attend Magic Millions raceday but DO NOT have a runner, please present your industry badge at the Industry Entrance and you will receive complimentary entry into the general admission. If you would like access into the member's areas please contact Magic Millions to request a pass. No members passes will be distributed on raceday by GCTC.

ALL TRAINERS please note to your owners who will have a horse running:

We will be applying the same ticket distribution system as ATC. Their tickets will give them all of the above excluding access INTO the horse stalls and all day access into the Mounting Enclosure.

Owners can access the viewing areas near the horse stalls and receive access to the mounting enclosure for their horse's race ONLY. From the 10th of January after the final fields have been announced, all Passes will be distributed to Owners and their guests as depicted below:



Our mounting enclosure is LIMITED TO 200 OWNERS PER RACE. Please ask that all syndicate managers nominate a replacement if they are not managing the syndicate for MM raceday.
