REGISTRATION PAYMENT SCHEDULE AND DEADLINES FOR 2018 FOALS

ELIGIBILITY A - QUEENSLAND SIRE

The progeny of any stallion standing in Queensland at the time of conception.

PAYMENT DEADLINES

1. FIRST PAYMENT

- A discounted First Payment of \$385 (GST inc) **made on or before 31 October 2019**; OR
- A Late First Payment of \$990 (GST inc) if First Payment is made after **31 October 2019** but on or before **31 July 2020**.

2. FINAL PAYMENT

A payment of \$550 (GST inc) **made on or before 31 July 2020**. This assumes a First Payment has already been made.

To be fully paid up and eligible to win QTIS bonuses, a **FIRST** and a **FINAL** payment must be made.

NO LATE ENTRIES WILL BE ACCEPTED

NOMINATIONS CANNOT BE PROCESSED UNLESS PARENTAGE HAS BEEN VERIFIED WITH THE AUSTRALIAN STUDBOOK

3. FULL PAYMENT

If a First and Final payment have not been made, full payment of \$1,540 (GST inc) is required to be paid on or before **31 July 2020** to fully QTIS register your horse.

ELIGIBILITY B - BREEDBACK

The progeny of a non-Queensland based stallion, provided the dam is covered by a Queensland domiciled stallion in the year the foal is born.

PAYMENT DEADLINES

1. FIRST PAYMENT

- A discounted First Payment of \$770 (GST inc) **made on or before 31 October 2019**; OR
- A Late First Payment of \$1,980 (GST inc) if First Payment is made after **31 October 2019** but on or before **31 July 2020**.

2. FINAL PAYMENT

A payment of \$550 (GST inc) **made on or before 31 July 2020**. This assumes a First Payment has already been made.

To be fully paid up and eligible to win QTIS bonuses, **FIRST** and **FINAL** payments must be made.

NO LATE ENTRIES WILL BE ACCEPTED

NOMINATIONS CANNOT BE PROCESSED UNLESS PARENTAGE HAS BEEN VERIFIED WITH THE AUSTRALIAN STUDBOOK

3. FULL PAYMENT

If a First and Final payment have not been made, full payment of \$2,530 (GST inc) is required to be paid by **31 July 2020** to fully QTIS register your horse.

2020/21 QTIS FEATURES INCLUDE:

- ✔ Standard bonuses across all 2YO & 3YO races held in Queensland (excluding Black Type, Feature and Magic Millions races).
- ✔ 50% increase to the standard QTIS bonus for 2YO, 3YO fillies and 4YO mares which win or place in a QTIS bonus race.
- ✔ A QTIS filly winning a Saturday Metropolitan QTIS bonus race takes home almost \$80K for her connections.
- ✔ A win in a Midweek Metropolitan QTIS bonus race will see registered colts & geldings net over \$28K and fillies approximately \$33K (in races other than maidens).
- ✔ The winning purse of a QTIS bonus race at a Non-TAB meeting for a registered colt, gelding or entire is \$8.5K, over \$10K for fillies and mares and is applicable to horses of all ages.
