QBRED AUSTRALIA'S BEST INCENTIVE SCHEME FOR BREEDERS AND OWNERS

QBRED is an incentive scheme delivering \$2 Million in additional returns for breeders and owners of harness horses bred and racing in Queensland.

With a lucrative range of exclusive stakes and bonuses on offer, only QBRED registered horses race for:

- \$10,000 QBRED 'First Win' Bonus
- \$7,500 QBRED 'Second Win' Bonus
- \$1,000 QBRED Cash bonuses (300 specified races per year)
- Exclusive rich QBRED Race Series

Some of harness racing's biggest stars have been QBRED registered, including Blacks A Fake, Be Good Johnny, Forever Gold, Majestic Mach, Leo's Best, Bettor Promise, Bettorthanspecial, Catcha Lefty, Colt Thirty One and Smart As Camm Be.

Connections of QBRED champions have received over \$19 Million in QBRED bonuses and \$8 Million in additional stakes.

NEW FOR 2019/20



The 2019/20 Racing Season opens an exciting new chapter of the QBRED bonus scheme, with the introduction of 'QBRED For Life'.

'QBRED For Life' removes the age restrictions on the first and second win bonus (providing the applicable entry fees are paid), while also offering access to the QBRED Cash Bonuses.

This means that QBRED benefits will be available to standarbreds of all ages.

This provides owners and breeders with enduring benefits and means there will now be less pressure to breed a horse early in the season and less pressure on horses having to win their bonus by the end of a season, while also ensuring horses that mature later in life maintain the opportunity to win lucrative bonuses for their connections.

QBRED ELIGIBILITY EXPLAINED

There are two (2) ways to reap the benefits of the QBRED Incentive Scheme and be eligible for a share of over \$2 Million on offer during the 2019/20 Queensland harness racing season. This is by breeding a QBRED Eligible Foal or purchasing a QBRED Eligible Foal.

BREED A QBRED ELIGIBLE FOAL

A foal is eligible to participate in the QBRED Incentive Scheme should it meet the criteria listed below:

- a mare inseminated in Queensland with the semen of any registered Standardbred stallion registered as standing in Queensland at the time of insemination, that produces a foal which is born and notified in Queensland;
- a mare inseminated in Queensland with the semen of any registered Standardbred stallion, that produces a foal which is born and notified in Queensland;
- a mare inseminated outside of Queensland with the semen of a Standardbred stallion registered with the Queensland Racing Integrity Commission (QRIC) and located in Queensland at the time of insemination, that produces a foal which is born in any state of Australia or overseas jurisdiction and the owner of that foal has paid the QBRED Foal Fee to Racing Queensland within 365 days of the foal being born;
- a mare inseminated outside of Australia, provided that the foal is born in Queensland and provided that the foal is not eligible for or participates in any other state based breeding scheme in any other Australian state or territory;
- a mare inseminated with the semen of a Standardbred stallion marketed as a trotting stallion standing anywhere in the world that is registered with Queensland authorities by an approved Queensland based semen distributor, (such a foal is a QBRED Eligible Foal).

PURCHASE A QBRED ELIGIBLE HORSE

A QBRED Eligible Foal may be purchased through private sale or from a public / yearling sale. Queensland hosts two public yearling sales each year, the Australian Pacing Gold Yearling Sale and the Garrards Redcliffe Yearling Sale.

HOW DO I NOMINATE A HORSE FOR QBRED?

To participate in the QBRED Incentive Scheme, a QBRED Eligible Foal must be nominated. Nominating a QBRED Eligible Foal to be part of the QBRED Incentive Scheme involves the following two easy steps:

- 1. At the time a QBRED Eligible Foal is born, the owner/breeder must pay Racing Queensland the QBRED Foal Fee as outlined in 'Nomination Fees' below. Making this payment means that the QBRED Eligible Foal is eligible to participate in the QBRED Incentive Scheme.
- **2.** The following, applicable sustaining payment is paid for the QBRED Eligible Foal:

For pacers - at the commencement of the pacer's 2YO, 3YO and 4YO or older racing season, payment by the owner to Racing Queensland of the relevant age sustaining payment enters that QBRED Eligible Foal into the QBRED Incentive Scheme, including QBRED Win Bonuses, QBRED Cash, the QBRED Triad Race series (for 2YO's, 3YO's & 4YO's) and the QBRED Breeders Classic (2YO's only) race series for the respective season. A full series sustaining payment is now also available see page 8 of this brochure for details.

For trotters - at the commencement of the trotter's 2YO, 3YO and 4YO or older racing season, payment by the owner to Racing Queensland of the relevant age sustaining payment enters that QBRED Eligible Foal into the QBRED Incentive Scheme including QBRED Win Bonuses, QBRED Cash, the QBRED Triad Race series (for 2YO's & 3YO's) for the respective season. A full series sustaining payment is now also available (see page 9 of this brochure for details).

QBRED BENEFITS

2019/20 QBRED WIN BONUSES

\$10,000 FIRST WIN BONUS

A 'first win' bonus of \$10,000 (**First Win Bonus**) will be paid where the following conditions are satisfied:

- the horse is a QBRED Eligible Foal aged 2YO or older in respect of which all QBRED Fees have been paid;
- the horse wins (or is in a dead heat to win) their first race in Queensland carrying prizemoney of more than \$4,500;
- the horse has never before won a First Win Bonus; and
- the First Win Bonus will be split between the owner and breeder as follows
 - 1. 90% to owner; and
 - 2. 10% to breeder

\$7,500 SECOND WIN BONUS

A 'second win' bonus of \$7,500 (**Second Win Bonus**) will be paid where the following conditions are satisfied:

- the horse is a QBRED Eligible Foal aged 3YO or older in respect of which all QBRED Fees have been paid;
- the horse wins (or is in a dead heat to win) their second race in Queensland which carries prizemoney of more than \$4,500 and is in a subsequent season to the horse either:
 - 1. winning the First Win Bonus; or
 - 2. winning a race in which it would have won the First Win Bonus but for the QBRED Fees not being paid,

- the horse has never before won a Second Win Bonus; and
- the Second Win Bonus is split between the owner and breeder as follows
 - 1. 90% to owner; and
 - 2. 10% to breeder.

NOTE: Winning multiple races worth more than \$4,500 in the same season as winning the First Win Bonus will not restrict eligibility to win the Second Win Bonus.

NOTE: Where all QBRED Fees are not paid up for horses in the season in which they qualify for either the First Win Bonus or the Second Win Bonus in accordance with these terms and conditions will not be eligible for the QBRED Win Bonuses forming part of the QBRED Incentive Scheme.

NOTE: The "4YO bonus" payable under previous QBRED Incentive Schemes is discontinued and no longer forms part of the QBRED Incentive Scheme.

QBRED CASH BONUS

A \$1,000 cash bonus (the **QBRED Cash Bonus**) will be paid to any QBRED Eligible horse for which all QBRED Fees are paid up of any age that wins (or is in a dead heat to win) a race specified as a "QBRED Cash Bonus race".

- The QBRED Cash Bonus is split between the owner and breeder as follows:
 - 1. 90% to owner; and
 - 2. 10% to breeder.

QBRED NOMINATION FEES

FOAL FEES

For a QBRED Eligible Foal to participate in the QBRED Incentive Scheme, a fee of \$99 (including GST) must be paid by the owner/breeder to Racing Queensland within the following timeframes:

- For an eligible foal notified in Queensland, the fee must be paid in accordance with the Racing Queensland invoice sent to the notifying party upon the foal being notified.
- For an eligible foal, **notified outside of Queensland**, within 365 days of that foal being notified, (such fee is the **QBRED Foal Fee**).

NOTE: The \$99 QBRED Foal Fee is NOT associated with the foal notification fees charged by the QRIC.

NOTE: Non-payment of the applicable Foal Fee will result in the foal no longer being eligible to enter the QBRED Incentive Scheme for its entire racing career.

SUSTAINING PAYMENTS

Subject to the QBRED Foal Fee having already been paid.

- 2YO Sustaining Payments are due by 31 October 2019; and
- 3YO and older Sustaining Payments are due by 31 August 2019.

Pacers - The relevant age Sustaining Payment must be paid by the owner by the above set deadlines for a pacer to be eligible for the QBRED Incentive Scheme (including QBRED Win Bonus Scheme, QBRED Cash Bonus, the QBRED Triad Race series, QBRED Breeders Classic race series and any other race restricted to QBRED horses).

Trotters - The relevant age Sustaining Payment must be paid by the owner by the above set deadlines for a trotter to be eligible for the QBRED Win Bonus Scheme, QBRED 2YO & 3YO feature races and any other race restricted to QBRED horses.

Should the prescribed Sustaining Payment not be paid by the above deadline, the pacer or trotter will not be eligible for any portion of the QBRED Incentive Scheme for the racing season commencing on 1 September 2019.

SUSTAINING PAYMENT FEE SCHEDULE

PACERS

2YO Sustaining Payment

Owners of a 2YO QBRED Eligible Foal that is a pacer have two options for maintaining the eligibility of their horse for the QBRED Incentive Scheme. The owner can either:

- A. pay a \$700 series fee (2YO Series Fee).

 A Series Fee is paid for life and provided that the QBRED Foal Fee has already been paid in respect of the QBRED Eligible Foal, no further payments will need to be made for the horse to participate in the QBRED Incentive Scheme; or
- **B.** pay a \$460 single year fee (**2YO Single Year Fee**). The 2YO Single Year Fee is paid for the 2YO season only.

3YO Sustaining Payment

To maintain the eligibility of their horse for the QBRED Incentive Scheme, owners of a 3YO QBRED Eligible Foal that is a pacer will need to:

- A. pay a \$240 single year fee (**3YO Final Fee**) if the 2YO Single Year Fee was paid in the 2018/19 season; or
- B. pay a \$460 single year fee (**3YO Single Year** Fee). The 3YO Single Year Fee is paid for 3YO season only (and is only payable if no previous Single Year Fees have been paid).

4YO & Older Sustaining Payment

To maintain the eligibility of their horse for the QBRED Incentive Scheme, owners of a 4YO or older QBRED Eligible Foal that is a pacer will need to:

- **A.** make no payment if two Single Year Fees have been previously paid;
- **B.** pay a \$240 payment (**4YO & Older Final Fee**) if one of the Single Year Fees have been paid in previous seasons; or
- C. pay a \$1,200 series fee (4YO & Older Series Fee). A Series Fee is paid for life if no previous Single Year Fees have been paid but the QBRED Foal Fee has been paid.

TROTTERS

To maintain the eligibility of their horse for the QBRED Incentive Scheme, owners of a trotter will need to:

- A. pay a \$400 series fee (2YOTrotters Series Fee) A series fee is paid for life and provided that the QBRED foal fee has been paid in respect of the QBRED eligible foal, no further payments will need to be made for the horse to compete in the QBRED Incentive Scheme:
- **B.** pay a \$230 single year fee for the 2YO season only (**2YO Trotter Single Year Fee**). The 2YO Trotter Single Year Fee is paid for the 2YO season only.
- C. pay a \$230 single season fee for the 3YO season only (3YO Trotter Single Year Fee). The 3YO Trotter Single Year Fee is paid for the 3YO season only (and is only payable if no previous Single Year Fees paid).
- D. pay a \$230 fee for Trotters 3YO or older (3YO + Final Fee) if only one of the Single Year Fees have been paid in previous seasons; or
- E. pay a \$700 series fee (4YO + Trotter Series Fee) if the QBRED Eligible Foal is 4YO or older and no previous Single Year Fees have been paid but the QBRED Foal Fee has been paid.

NOTE: Where the QBRED Foal Fee and if two or more Single Year Fees are paid, a QBRED Eligible horse will be treated as if the Series Fee had been paid in respect of it.

LATE PAYMENTS

Should the relevant QBRED Foal Fee, Series Fee or Single Year Fee not be paid by the prescribed date for any horse, regardless of whether a pacer or trotter, that horse will not be eligible for any portion of the QBRED Incentive Scheme for that season.

LATE PAYMENTS WILL NOT BE ACCEPTED and only those horses that are paid into the QBRED Incentive Scheme by the specified closing dates set out above will be eligible to receive benefits from the QBRED Incentive Scheme.

DEFINED TERMS

In these terms and conditions:

QBRED Fees means the QBRED Foal Fee and a Series Fee or any two or more Single Year Fees;

Series Fee means any of the 2YO Series Fee, 2YO TrottersSeries Fee, 4YO Series Fee or 4YO+ Series Fee; and

Single Year Fee means any of the 2YO Single Year Fee, 2YO Trotter Single Year Fee, 3YO Single Year Fee, 3YO Trotter Single Year Fee, 3YO Final Year Fee, 3YO & Older Final Fee, 4YO & Older Final Year Fee and any equivalent single year sustaining payments made under and in accordance with previous QBRED Incentive Schemes.

Any capitalised terms not otherwise defined have the meaning given to them in the Australian Harness Racing Rules published by Harness Racing Australia.

MULTIPLE ELIGIBILITY

Any horse that is a QBRED Eligible Foal may remain eligible for any other State or Territory schemes subject to the terms and conditions of such schemes. Being eligible for any other State or Territory schemes does not preclude entry or eligibility to QBRED other than foals born in Queensland from mare inseminated outside of Australia, which are only eligible for those incentive schemes listed in QBRED Eligibility above.

GENERAL DISCLOSURE

Racing Queensland has the power to deal with any matter arising which is not specifically covered in these conditions. Any decision by Racing Queensland shall be final and binding on all parties.

Racing Queensland may change any part of these terms and conditions at any time and at Racing Queensland's absolute discretion.

While Racing Queensland will endeavor to contact the owners of QBRED Eligible Foals or horses eligible to participate in the QBRED Incentive Scheme to notify them of the fees and deadlines for payment, it is the breeders/owner/s full responsibility to ensure that all necessary payments have been made for their horse/s for the QBRED Incentive Scheme in accordance with these terms and conditions.

These terms and conditions supersede all previous terms, conditions or agreements about its subject matter. To the extent permitted by law, any statement, representation or promise made in any negotiation, advertisement or discussion has no effect except to the extent expressly set out or incorporated by reference in this document.
