# REGISTRATION PAYMENT SCHEDULE AND DEADLINES FOR 2024 FOALS

## ELIGIBILITY A - QUEENSLAND SIRE

The progeny of any stallion standing in Queensland at the time of conception.\*

\* Subject to the QTIS and QTISx terms and conditions as posted on the Racing Queensland website.

### PAYMENT DEADLINES

#### 1. FIRST PAYMENT

- A discounted First Payment of \$385 (GST inc) **made on or before 31 October 2025**; OR
- A Late First Payment of \$990 (GST inc) if First Payment is **made after 31 October 2025 but on or before 30 June 2026**.
- If no first payment is received on or before June 30 the Horse will not be eligible for QTIS.

#### 2. FINAL PAYMENT

A payment of \$550 (GST inc) **made on or before 30 June 2026**. This assumes a First Payment has already been made.

#### 3. FULL PAYMENT

If a First and Final payment have not been made, full payment of \$1,540 (GST inc) is required to be paid on or before **30 June 2026** to fully QTIS register your horse.

#### 4. LATE PAYMENT

A late payment option is available for horses not fully registered by **30 June 2026**. The fee is \$2,500 (GST inc) and is required by **31 August 2026**.

If no final payment is received on or before August 31 the Horse will not be eligible for QTIS.

**As per Racing Queensland's T&C's all Australian Studbook obligations must be met.  
NOMINATION IS NOT REQUIRED FOR ELIGIBILITY A.**

## ELIGIBILITY B - BREEDBACK

The progeny of a non-Queensland based stallion, provided the dam was covered by a Queensland domiciled stallion in the year the foal being registered was born\*

\* Subject to the QTIS and QTISx terms and conditions as posted on the Racing Queensland website.

### PAYMENT DEADLINES

#### 1. FIRST PAYMENT

- A discounted First Payment of \$770 (GST inc) **made on or before October 31, 2025**; OR
- A late First Payment of \$1,980 (GST inc) if First Payment is **made after October 31, 2025 but on or before June 30, 2026**.
- If no first payment is received on or before June 30 the horse will not be eligible for QTIS.

#### 2. FINAL PAYMENT

A payment of \$550 (GST inc) **made on or before June 30, 2026**. This assumes a First Payment has already been made.

#### 3. FULL PAYMENT

If a First and Final payment have not been made, full payment of \$2,530 (GST inc) is required to be paid by **June 30, 2026** to fully QTIS register your horse.

#### 4. LATE PAYMENT

A late payment option is available for horses not fully registered by **June 30, 2026**. The fee is \$1,500 (GST inc) and is required by **August 31, 2026**.

If no final payment is received on or before August 31, the horse will not be eligible for QTIS.

1. To be fully paid up and eligible to win QTIS bonuses, a FIRST and a FINAL payment must be made.
2. Horses are not eligible for the Queensland Thoroughbred Incentive Scheme if no first payment is received on or before June 30, 2026.
3. Registrations will not be processed until verification of parentage is provided.
4. Racing Queensland makes every endeavour through all available mediums/channels to advise stakeholders of QTIS registration obligations, and the deadlines associated with them. The onus however is on Breeders/ Owners of horses to ensure that the appropriate commitments (for which the deadline dates have not changed year-on-year) are met and accordingly, the non-receipt of personalised communications (e.g. emails etc) from RQ will not constitute a valid reason for non-compliance and clemency to be exercised.
