



# QUEENSLAND OFF-THE-TRACK

# SUBSIDISED LESSONS PROGRAM TERMS AND CONDITIONS

## 1 GENERAL

- 1.1 Queensland Off-The-Track ('**QOTT**') is an independent business unit of Racing Queensland Board (ABN 80 730 390 733), Lot 2, Racecourse Road, Deagon in Queensland. QOTT operates and authorises all QOTT programs, including this QOTT Subsidised Lessons Program ('**Program**') that you are participating in.
- 1.2 These terms and conditions govern the participation of you as a Participant in the Program, or involvement in the Program as a Guardian of a Participant under eighteen (18) years of age. By signing this document, you accept these terms and conditions in full.

# 2 INTERPRETATION

2.1 In these terms and conditions, the following definitions apply:

Approved Coaches	means a coach approved by QOTT who will conduct your subsidised horse coaching lessons.	
Eligible Horse	means a Thoroughbred or Standardbred horse approved by QOTT, which:	
	(a)	is a Thoroughbred or Standardbred that has been, or is eligible to be, registered for thoroughbred racing or harness racing in Australia; and
	(b)	a decision has been made not to race the horse, or the horse has retired from racing, race training and/or breeding; and
	(c)	the horse:
	(i)	was bred in Queensland but was unraced; or
	(ii)	has started in an official barrier trial or race in Queensland, and was domiciled in Queensland at the time of its retirement, as per Racing Australia or Harness Racing Australia records; or
	(iii)	is a broodmare or stallion and was domiciled in Queensland at the time of its retirement, as per Racing Australia or Harness Racing Australia records.
Participant	means an applicant or participant in the Program and can include Minors.	
Guardian	means each parent or guardian of a Minor who completes the Program application and signs the terms and conditions.

Minor	means a person participating in this Program who is under eighteen (18) years of age.
Standardbred	means a horse which is or has been, or is eligible to be, registered for harness racing in Australia.
Thoroughbred	means a horse which is or has been, or is eligible to be, registered for thoroughbred racing in Australia.
you and your	means you participating in this Program as a Participant, or as a Guardian of a Participant that is a Minor.

#### 3 PURPOSE

- 3.1 The Program enables Participants who have previously acquired an Eligible Horse to obtain subsidised horse coaching lessons conducted by Approved Coaches.
- 3.2 The purpose of the Program is to ensure that Participants can undergo training and learn the vital skills to care for and ride an Eligible Horse. Lessons can cover a variety of areas, including horse and rider education and training, as well as equestrian activities. Participants are responsible for negotiating the content of the lessons with the Approved Coach.

## 4 YOUR OBLIGATIONS

- 4.1 Each Participant, and in the case of a Minor each Guardian, must follow all reasonable safety directions and guidance provided by any Approved Coach or QOTT.
- 4.2 To ensure the health and safety of Participants, and any Approved Coach, prior to any lessons you must notify each Approved Coach:
  - (a) of any physical disabilities that a Participant has, so that the Approved Coach can assess risk and limitations before the Eligible Horse is handled; and
  - (b) whether a Participant is taking any medication which may physically or mentally alter motor functioning or physical capabilities; and
  - (c) whether the Eligible Horse has any known behavioural issue; and
  - (d) whether the Eligible Horse has an injury or illness, or is taking any medication,

so that the Approved Coach can assess risk and limitations before lessons begin.

- 4.3 Participants must always wear a helmet whilst riding an Eligible Horse and any appropriate safety attire recommended by the Approved Coach.
- 4.4 Participants must behave safely and responsibly during the lessons and not engage in behaviour such as running, yelling and screaming, as this may frighten the horse and place their safety, or the safety of others, at risk.
- 4.5 At all times the Guardian must supervise each Minor who is a Participant.
- 4.6 Participants must not use more than one (1) coaching lesson voucher per Eligible Horse per day.
- 4.7 Participants must ensure that the Eligible Horse has had a minimum six week let down period from racing activities prior to commencing retraining/ridden activities in the Program.

## 5 PROCEDURE

- 5.1 Participants must have a Queensland residential address to apply to participate in the Program.
- 5.2 Participation in the Program will require completion of the application form for subsidised horse coaching lesson vouchers on the QOTT website and the accompanying instructions must be followed.
- 5.3 Applicants must contact their preferred Approved Coach prior to nominating the Approved Coach on the application form to confirm the Approved Coach's availability, suitability and location for where the lessons will be held. Participants are not permitted to change their Approved Coach once the application form has been submitted.
- 5.4 QOTT will assess completed application forms after they have been submitted and will decide whether the person seeking to participate in the Program is approved. QOTT will assess and decide all applications within fourteen (14) business days or such further period as determined by QOTT, and all decisions are made at QOTT's sole discretion.
- 5.5 QOTT may determine and change the application process to participate in this Program at any stage at its sole discretion.
- 5.6 Following approval by QOTT to participate in the Program, QOTT will email a copy of these terms and conditions to you. You must sign and return a copy of these terms and conditions to be a Participant or Guardian in the Program within one (1) month of the date of QOTT's email or your participation in the Program will be cancelled.
- 5.7 Once QOTT has received a signed copy of these terms and conditions, Participants who have been approved with an Eligible Horse that:
  - a) has retired directly from racing, race training, and/or breeding within the eighteen (18) months prior to the date of application, will receive ten (10) subsidised horse coaching lesson vouchers, in a manner and form decided by QOTT. These vouchers will entitle Participants to ten (10) free horse coaching lessons with one of QOTT's Approved Coaches.
  - b) has been retired from racing, race training, and/or breeding for longer than eighteen (18) months at the date of application, will receive three (3) subsidised horse coaching lesson vouchers, in a manner and form decided by QOTT. These vouchers will entitle Participants to three (3) free horse coaching lessons with one of QOTT's Approved Coaches.
- 5.8 Each horse coaching lesson can be up to 45 minutes in duration.
- 5.9 Approved Participants are issued with horse coaching lesson vouchers for use with the Approved Coach nominated on the application form. Participants are not permitted to change their Approved Coach once the application has been approved and all horse coaching lesson vouchers must be used with the nominated Approved Coach.
- 5.10 Vouchers for horse coaching lessons must be used between the date of issue and date of expiry noted on the voucher, subject to clause 5.11.
- 5.11 To apply for an extension to the expiry date of coaching lesson vouchers, a medical certificate (Participant) or a veterinary certificate (Eligible Horse) is to be provided to QOTT detailing the incapacitation period of the Participant and/or Eligible Horse. Extensions to the expiry date of coaching lesson vouchers will be granted at QOTT's sole discretion. If an

extension is granted, QOTT will provide an extension to the expiry date of the coaching lesson vouchers in accordance with the length of the incapacitation period stated on the medical certificate or veterinary certificate.

- 5.12 Participants can only use vouchers issued in their name for use with the nominated Eligible Horse and vouchers cannot be exchanged with other participants in the Program.
- 5.13 Once you have received your horse coaching lesson vouchers, you are responsible for contacting the Approved Coach that will be conducting the lessons to confirm a location and time for the lessons. Lessons can only be held at the Approved Coach's property or such other venue agreed with the Approved Coach, and not at any venue operated by QOTT. Alternatively, lessons can be conducted via online meeting platforms.
- 5.14 If lessons will be conducted at the Approved Coach's property or such other venue that requires the transportation of the Eligible Horse, you are responsible for transporting the Eligible Horse to and from the location.
- 5.15 Approved Coaches may suspend any lesson if it is deemed unsafe to continue. Any lessons that are suspended and not able to be completed, may be completed at a future time to be negotiated with the Approved Coach.
- 5.16 Participants may only apply for lessons on the same Eligible Horse once per twelve (12) month period. Therefore, a new application can be submitted after the expiry date has been reached on the previously issued coaching lesson vouchers.

# 6 MINORS

- 6.1 To participate in this Program, Minors must be at least twelve (12) years of age.
- 6.2 If you are the Guardian of a Minor who is participating in this Program, you warrant that you have the authority to sign these terms and conditions on behalf of them, you consent to the Minor participating in the Program, and agree to these terms and conditions without limitations.

## 7 DISCLAIMER

- 7.1 QOTT makes no warranty, guarantee or claim regarding the skills or training that Participants may receive from the horse coaching lessons provided by an Approved Coach or any suitability of an Eligible Horse for any subsequent use.
- 7.2 QOTT does not accept any responsibility for any loss, damage or injury, whether direct or indirect, arising from your participation in this Program.
- 7.3 You participate in this Program entirely at your own risk. You acknowledge that any activity involving horses, due to their nature and size, is inherently hazardous and dangerous and may result in injury, loss, damage or death to yourself or others located in the area of the lessons.
- 7.4 You acknowledge that any sudden movement, noise or other activity may result in an Eligible Horse becoming frightened and acting in an unpredictable way. If a Minor is a Participant in this Program, their Guardian must bring this to their attention and explain this to them.
- 7.5 You acknowledge the dangers associated with the consumption of alcohol or any mindaltering drugs before and during any horse-related activities and you take full responsibility for any injury, loss or damage associated with their consumption. Participants must not drink

alcohol or take any non-prescribed drugs prohibited by law before or during participation in the Program.

7.6 You acknowledge that any venue where a Participant attends to undertake horse coaching lessons, or any facilities that Participants use in the course of doing so, is entirely at their own risk and you accept this risk.

## 8 INDEMNITY AND RELEASE

- 8.1 QOTT will not be liable for and accepts no liability for any actions, claims, costs or liability in relation to the coaching lessons provided by an Approved Coach under this Program. You expressly release QOTT from any and all claims, demands, actions or otherwise of any nature or kind.
- 8.2 You indemnify and keep indemnified QOTT against any and all loss, claims, costs, liability, charges, expenses penalties, demands or damages whatsoever which may be brought or made against QOTT arising in relation to the lessons provided by an Approved Coach under the Program.

## 9 ROLE OF QOTT

- 9.1 QOTT only has the responsibility to ensure that the administrative aspect to the Program is operating correctly, including assessing application forms, providing horse coaching lesson vouchers, and engaging Approved Coaches to provide horse coaching lessons to Participants in the Program.
- 9.2 QOTT is not involved with organising dates, locations and times for Participants regarding any horse coaching lessons.
- 9.3 QOTT may, in its sole discretion, cancel this Program, or cancel your participation in the Program for any reason or at any time, including voiding any horse coaching lesson vouchers that have been provided. QOTT will not be responsible for any loss, cost, damage or liability that may arise as a result.

## 10 BREACH OF TERMS AND CONDITIONS

10.1 Without prejudice to QOTT's other rights under these terms and conditions, if you breach these terms and conditions in any way, QOTT may take such action as it deems appropriate to deal with the breach, including, but not limited to, suspending or deleting your participation in the Program.

#### 11 VARIATION

11.1 QOTT reserves the right to make changes to these terms and conditions from time to time and at its sole discretion. Revised terms and conditions will govern your participation in the Program, and you will be notified about where to obtain a copy of these. By continuing to participate in the Program, you accept the revised terms and conditions in full. You must not continue participating in the Program if you do not accept the revised terms and conditions.

#### 12 SEVERABILITY

12.1 If any of these terms and conditions (or part thereof) are determined by any competent authority to be invalid, unlawful or unenforceable to any extent, such term, condition or provision (or part thereof) will to that extent be severed from the remaining terms and conditions which will continue to be valid to the fullest extent permitted by law.

# 13 JURISDICTION

13.1 These terms and conditions will be governed by and construed in accordance with the laws in the State of Queensland, and any disputes relating to these terms and conditions will be subject to the exclusive jurisdiction of the courts of Queensland.
